# Community Preparedness Program Report (Q2 2025)

# **Executive Summary**

During the second quarter of 2025, community preparedness programs across Texas demonstrated strong activity and engagement across training, exercises, meetings, and outreach. Nearly all reporting programs contributed meaningful activity, underscoring the continued value of these initiatives in strengthening local resilience.

#### Training

• Total Trainings Reported: 112

- CERT: 103 - MRC: 7 - Fire Corps: 2

- VIPS & USA on Watch: 0

Training activity was led by CERT programs, with Harris County Citizen Corps accounting for 61 trainings alone. Many other teams contributed steadily with 2–5 trainings each.

#### **Exercises**

Total Exercises Reported: 36Programs Participating: 14 of 22

Exercises included hurricane preparedness, line search drills, vehicle response, and community-based scenarios.

### Meetings

• Total Meetings Reported: 104

Programs Hosting Meetings: 17 of 22

Meetings served as a core activity for coordination, volunteer engagement, and sustaining operational readiness.

#### **Activities**

• Programs Reporting Activities: 21 of 22

Activities included support for community events (such as fairs, festivals, and drills), public education, preparedness campaigns, and direct support for emergency drills. These efforts reflect the versatility of programs in combining operational support with public outreach.

# Community Preparedness Program Report (Q2 2025)

#### Introduction

This report provides a comprehensive overview of activities conducted by Community Preparedness Programs across Texas during the second quarter of 2025 (April 1 – June 30, 2025). The reporting period highlights the ongoing commitment of local programs and volunteers to strengthen community resilience through training, exercises, meetings, and outreach activities.

Across the state, programs demonstrated significant engagement, from large urban teams hosting multiple trainings and exercises to smaller community-based groups steadily supporting local events and preparedness initiatives. Collectively, these efforts reflect a strong emphasis on volunteer development, operational readiness, and public education—core elements of the mission to build safer, more resilient communities.

The information contained in this report summarizes the contributions of 22 reporting programs, offering both statewide totals and detailed program-level appendices. This provides a clear picture of the diverse ways Community Preparedness Programs continue to serve their regions and enhance preparedness across Texas.

# Community Preparedness Quarterly Report (Q2 2025)

### **Training Summary (Q2)**

During the second quarter of 2025, a total of 22 programs submitted training reports, with 15 programs actively hosting training. Community Emergency Response Team (CERT) programs remain the most active component of training statewide, collectively reporting 103 training courses. Harris County Citizen Corps accounted for the largest share, with a total of 61 training courses, while many smaller programs consistently hosted between two and five training courses each. Medical Reserve Corps (MRC) training activity was more modest, with seven trainings reported, while Fire Corps reported two trainings total. No training activity was reported under Volunteers in Police Service (VIPS) or USA on Watch this quarter.

Most activities were small-scale (1–2 events), while a few programs hosted multiple exercises. ## **Meeting Summary (Q2)**

Programs across the state reported hosting a total of 104 meetings this quarter. Out of 22 reporting programs, 17 held at least one meeting. These gatherings provided an essential forum for planning, training support, and maintaining connections among volunteers, agencies, and partners.

# Community Preparedness Program Report (Q2 2025)

#### Conclusion

The second quarter of 2025 reflects strong and sustained engagement by Community Preparedness Programs across Texas. Nearly all reporting programs submitted meaningful contributions, underscoring the statewide commitment to resilience and volunteerism.

#### Key successes this quarter include:

- **High training output** led by CERT teams, with both large urban programs and smaller local groups contributing consistently to volunteer readiness.
- **Diverse exercise participation** across 14 programs, providing communities with hands-on preparedness experience through scenarios such as hurricane response, severe weather drills, and public health exercises.
- Strong coordination through meetings, with 104 gatherings reported, demonstrating the importance of routine communication in sustaining active and organized volunteer networks.
- Broad community engagement through activities that ranged from supporting festivals and fairs to conducting targeted outreach and preparedness campaigns.

#### Statewide patterns show a clear emphasis on:

- **CERT as the backbone** of community preparedness, accounting for the vast majority of reported training.
- **Partnerships with public events** as a primary strategy for outreach and visibility, connecting preparedness messages to diverse audiences.
- **Consistency across regions,** with both urban and rural programs finding ways to adapt activities to local needs while contributing to statewide goals.

Taken together, these patterns underscore the resilience of Texas communities and the crucial role that preparedness programs play in enhancing safety, readiness, and public education. Q2 demonstrates that when programs engage volunteers consistently and align with community events, they both strengthen operational capacity and foster lasting public trust.
