#### **Adult Sexual Assault in Texas**

- Texas Penal Code 22.011
- UT Prevalence study -roughly 1/3 of Texas women experience sexual violence in their lifetime
- Reporting to LE
- Case outcomes for ASA

#### What is a SART?

- Formal, coordinated response to sexual assault by community stakeholders
- Evidenced based model of addressing interpersonal crimes of violence in a particular geographic area
- Public & private stakeholders
- Communication, evaluation, protocol development
- Victim safety, offender accountability & healing



Addressing a consistent and far reaching lack of:

- Communication
- Coordination
- Transparency
- Accountability
- Sensitivity
- Training

#### **Lessons Learned**

Commitment from agency leaders & succession planning

**Real participation** 

Shared purpose

Write it down

**Relationship building** 

Challenges reported: internal conflict, lack of prosecution and focus on CSA or DV

#### SB476 Structure

Over 250k- must convene their own team

Umbrella- County Commissioner's Court

- Establish a team and appoint statutory membership
- Receive reports every 2 years

#### Statutory membership(1 of each-minimum)

- **1**. A Sexual Assault Program that provides services in the county
- 2. A Prosecutor with jurisdiction over SA cases
- **3.** A Sheriff or designee
- 4. Largest Municipal Law Enforcement Agency
- 5. A Mental Health Provider that provides services in the county
- 6. A Sexual Assault Forensic Examiner that conducts exams within the county
- 7. Other individuals or entities determined by the team

#### **Resource Mapping**

- How many of **each** of these 6 entities do we have in our county? Who is currently involved in Adult SA response?
- How do these agencies respond by population or geography?
- Has anyone reached out from these professions to get things rolling?
- For new teams, start talking with the core group and then build out as needed

#### **Resource Mapping Scenarios**

What if our county has.....2 Sexual Assault Programs, 3 SANE programs, 6 MH programs....

Or 3 Sexual Assault Programs, 50 LE agencies, 2 Prosecutors.....



#### Planning for protocol

To develop an effective protocol, ensure you have the primary responding agencies at the table, or at least on board with what is developed for the community.

People are permitted to attend meetings at the team's discretion, even without being official members. This will allow time for new teams to figure out who else to invite and how to organize.

#### **Potential Members/Attendees**

- Domestic violence agencies
- Crime lab
- Survivors
- Campus personnel

#### Meetings- new teams

- 1<sup>st</sup> meeting to be held by December 1<sup>st</sup>, 2021
- Frontload infrastructure
  - Conflict resolution process
  - Schedule & leadership
  - Information sharing processes
  - Decision making

#### Meetings- existing teams

- Begin discussions with active members around integrating new requirements
- Ensure that meetings are happening regularly
- Appoint members and formalize the group as needed to comply with statute
- Team should have input on additional members or attendees
- Existing teams may not have a written protocol yet

**Team Leadership** 

Large counties=higher population=more agencies= more infrastructure

SARTs use a mix of leadership methods

- Steering committee
- Coordinator & Chair
- Co-Chairs/Co-Presiding Officers
